Privacy Statement

Pigeon House Cottage (“PHC”) is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Privacy Statement applies to the PHC website and governs data collection and usage. By using the PHC website, you consent to the data practices described in this statement.

Collection of your Personal Information

PHC collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. PHC also collects anonymous demographic information, which is not unique to you, such as your postcode, age, gender, preferences, interests and favourites.

There is also information about your computer hardware and software that is automatically collected by PHC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by PHC for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the PHC website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through PHC public message boards, this information may be collected and used by others. Note: PHC does not read any of your private online communications.

PHC encourages you to review the privacy statements of websites you choose to link to from PHC so that you can understand how those websites collect, use and share your information. PHC is not responsible for the privacy statements or other content on websites outside of the PHC website.

Use of your Personal Information

PHC collects and uses your personal information to operate the PHC website and deliver the services you have requested. PHC also uses your personally identifiable information to inform you of other products or services available from PHC. PHC may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

PHC does not sell, rent or lease its customer lists to third parties. PHC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, PHC may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support. All such third parties are prohibited from using your personal information except to provide these services to PHC, and they are required to maintain the confidentiality of your information.

PHC does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

PHC keeps track of the pages our customers visit through the PHC website, in order to determine what PHC services are the most popular. This data is used to deliver customised content to customers whose behaviour indicates that they are interested in a particular subject area.

PHC website may disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on PHC or the site; (b) protect and defend the rights or property of PHC; and, (c) act under exigent circumstances to protect the personal safety of users of PHC, or the public.

Use of Cookies

The PHC website use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the web server that you have returned to a specific page. For example, if you personalize PHC pages, or register with PHC site or services, a cookie helps PHC to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same PHC website, the information you previously provided can be retrieved, so you can easily use the PHC features that you customized.

You have the ability to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the PHC services or websites you visit.

Security of your Personal Information

PHC secures your personal information from unauthorized access, use or disclosure. PHC secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

Changes to this Statement

PHC will occasionally update this Privacy Statement to reflect customer feedback. PHC encourages you to periodically review this statement to be informed of how PHC is protecting your information.
